The display area includes outside areas for canopies, etc. There will be no electricity available in outside areas. Pavilion I is open air (under roof, but open sided), on concrete floor. No more than two tables or spaces per display. No refunds! Non-transferable!

First come, first served. You are responsible for collecting and reporting your own Florida State Sales Tax.

For your convenience, the park will be open on Friday, April 13, 12:00 noon to 5:00 p.m., for check-in and setup of displays and canopies.

No security will be provided overnight. Those with a self-contained vehicle or RV may stay in the park Friday night only (no hook ups or facilities) for \$21.20 (includes Florida State Sales Tax).

Setup on Saturday morning begins at 7 a.m. and is required to be completed (vehicles parked) by 8:30 a.m.

All crafters are required to remain until the end of the festival at 4 p.m.

Alcoholic beverages are not allowed. Smoking is not permitted under the pavilion.

Registration form and fees will be accepted starting 8:00 a.m., Monday, February 6, and must be received by 4:00 p.m., Friday, April 6, 2012.
